#### Your personal data may be processed in order to:

1. Market the products/services and to communicate in form of written or electronic correspondence or with the use of telecommunications devices (telephones, Text Messages).

2. Transfer and exchange information about Delia Cosmetics' products and shipping of products for testing.

3. Provide access to data to organizers /partners of organized marketing campaigns in order to enable them to communicate with the participant or to market their services - in the form of written or electronic correspondence or using telecommunications equipment (e.g. telephones, Text Messages).

- 4. Handle the recruitment process.
- 5. Handle the complaints and secure claims.
- 6. Handle the inquiries received via forms, e-mail.
- 7. Cooperate with trade partners in the scope of the conducted activity.

# The recipients of your personal data may be:

1. Companies related to the Delia Capital Group: Delia Cosmetics Distribution Sp. z o. o, and Capitol Sp. z o.o.,

2. Polish Post-Office and other courier companies

3. In case of orders from outside the EU, personal data will be processed by courier companies, which provide the execution of the order, in particular, in the country of the recipient's order.

# The period of time for which your personal data will be stored is:

Your personal data will be archived until we receive a request to delete it.

# Providing your personal data and the consent to process it

Providing your personal data is voluntary, however, it is necessary for the cooperation to take place. Not providing personal data will result in the following consequences:

- 1. No ability to start marketing cooperation.
- 2. No possibility to participate in the recruitment process.
- 3. No possibility to handle complaints and secure claims.
- 4. No possibility to answer questions sent in the form or by email
